The exact release date for the Long-Term Contracts for Energy Storage Projects remains "TBD," though a tentative schedule in the draft suggests a public release of the RFP on July 31,2025. The RFP includes scheduled periods for questions and feedback through the fall,with proposal submissions due by Sept. 10.

What is Massachusetts' energy storage procurement?

The energy storage procurement aligns with Massachusetts' 2024 legislation,An Act Promoting a Clean Energy Grid,Advancing Equity and Protecting Ratepayers,which directs the state to procure energy storage totaling 5 GWby July 31,2030. The procurement targets 3.5 GW of mid-duration storage (four to ten hours),totaling 14,000 to 35,000 MWh.
