What is ecuapass & how does it work in Ecuador?

ECUAPASS is required to clear all shipments entering Ecuador. An electronic signature or token is also required for submissions in ECUAPASS and must be obtained with the Central Bank in Ecuador (BCE). Includes import documentation and other requirements for both the U.S. exporter and foreign importer.

What are the import requirements in Ecuador?

Import Requirements and Documentation All importers must register with the Ecuadorian Customs Service (SENAE) as well as obtain a company tax number(RUC) issued by the Ecuadorian Internal Revenue Service (SRI). The following documentation is required to import products into Ecuador:

What is the National Customs Service of Ecuador?

The National Customs Service of Ecuador (Servicio Nacional de Aduana del Ecuador- SENEDE) is a pivotal resource, offering tools and guides that help traders navigate the complexities of customs and other regulatory requirements.

Do I need a permit to import a plant in Ecuador?

Plants - a phytosanitary certificate and permit from the Ministry of Agriculture are required prior to import. Recommended: Contact the destination agent to ensure all requirements for the customs regulations in Ecuador have been met prior to import, especially for differences regarding air/sea shipments.
