Do you pay excise taxes in Haiti?

Excise taxes may be either specific or value-added. Locally manufactured cigarette firms are required to pay 50 percent duty on product value. Heavy agricultural and public works machinery are exempt from paying excise duties. Haiti has World Trade Organization (WTO) bound import duties on agricultural and non-agricultural products.

Do I need a DPI before shipping to Haiti?
