What is the bulk energy storage program?

The Bulk Energy Storage Program will use an innovative Index Storage Credit incentive, as established in the Order and modeled in part on the Renewable Energy Certificate (REC) and Offshore Wind Renewable Energy Credit (OREC) utilized in other NYSERDA programs.

When did NYSERDA implement the bulk energy storage program?

On June 12, 2025, NYSERDA filed the original Bulk Energy Storage Program Manual with the Public Service Commission. On March 21, 2025 the Commission issued an Order Approving Bulk Implementation Plan with Modifications [PDF].
