Do solar panels need an export MPAN?

Before they can sell electricity to the grid, solar panel owners must be assigned an export MPAN. This is a crucial step in signing up for an export tariff - a type of tariff that suppliers initially created out of obligation, after the government launched the Smart Export Guarantee (SEG) in 2020.

How much money can you make exporting solar energy?

If you choose one of the best export tariffs, you can earn £343 per year. That figure is based on a household using 3,400 kWh of electricity per year (the UK average) with solar irradiance of 850 kWh per kilowatt-peak (kWp), a 4.6kWp solar panel system, and a 5.2kWh battery. Who creates your export MPAN?
