Host Customer and/or Owner contract information (name,email,address,phone)Provide the total number of megawatts of solar PV your firm has constructed over the last five (5) years. Provide the total number of megawatts of solar PV your firm has constructed over the last five (5) years in New York.

What are the requirements for a solar energy system?

Solar Energy Systems larger than acres shall be required to: I. Conduct a visual assessment of the visual impacts of the Solar Energy System on public roadways and adjacent properties. At a minimum, a line-of-sight profile analysis shall be provided.

What information should be displayed on a solar energy system?

No signage or graphic content shall be displayed on the Solar Energy Systems except the manufacturer's name, equipment specification information, safety information, and 24-hour emergency contact information. Said information shall be depicted within an area no more than square feet.
